FACTUAL BACKGROUND

Appellant filed his brief on June 10, 2015, in an accelerated appeal. Appellee's counsel requested additional time because of an unexpected death in the Taylor, Dunham, and Rodriguez family, which created uncertainty in the

firm's docket. The requested extension was identified as the appellee's first request, was not sought for delay, and was unopposed by Appellant.

PROCEDURAL HISTORY

Appellant filed his brief on June 10, 2015, in an accelerated appeal. Appellee's brief was due June 30, 2015, and Appellee filed an unopposed motion requesting that the deadline be extended to July 20, 2015. The provided text contains the motion but no judicial ruling on it.
