SUMMARY

The Fifth District Court of Appeals at Dallas ordered the court reporter to file the reporter's record or verify that the appellant had not requested its preparation. The court warned that, upon such verification, it would submit the appeal without the reporter's record.

1. What action should the appellate court take when the reporter's record has not been filed and the court reporter reports that the appellant may not have requested its preparation?

“Accordingly, we ORDER court reporter Francheska Duffey, to file by MARCH 14, 2013, either the reporter’s record or written verification that appellant has not requested preparation of the record.” (Order)

FACTUAL BACKGROUND

The appeal lacked a reporter's record. The court reporter reported that she had not received a designation of the record from appellant, and neither appellant nor the court reporter had subsequently communicated with the appellate court regarding the record.

PROCEDURAL HISTORY

Maurice Murphy appealed from the 330th Judicial District Court of Dallas County, Texas, in trial court cause number DF-11-06133Y. After the appellate court ordered the court reporter to file the reporter's record, the reporter stated that appellant had not designated the record, and no reporter's record or further communication was received. The court entered this order requiring the reporter to file the record or written verification by March 14, 2013.
