

SUPREME COURT OF THE STATE OF OKLAHOMA

In the Matter of the Reinstatement of Brandy Kearney Chambers

2025 OK 88 · No. SCBD-7913 · Decided December 8, 2025

SUMMARY

The Oklahoma Supreme Court granted Brandy Kearney Chambers's petition for reinstatement to active membership in the Oklahoma Bar Association, effective January 1, 2026. The Court found that she satisfied the applicable procedural requirements and established her competency, good moral character, and lack of unauthorized practice. The Court also ordered her to pay \$972.80 in proceeding costs, complete annual continuing legal education, and pay 2026 bar dues.

QUESTIONS PRESENTED

1. Whether Chambers satisfied the procedural requirements for reinstatement to the Oklahoma Bar Association.
2. Whether Chambers established by clear and convincing evidence that she had not engaged in the unauthorized practice of law.
3. Whether Chambers established the competency, legal learning, and good moral character required for reinstatement.

HOLDINGS

1. Chambers satisfied the procedural requirements and established by clear and convincing evidence that she had not engaged in unauthorized practice and possessed the competency, legal learning, and good moral character required for reinstatement; therefore, her petition was granted effective January 1, 2026.
2. Chambers was ordered to pay \$972.80 in proceeding costs within sixty days, complete accredited continuing legal education annually, and pay \$350 in 2026 bar dues.

FACTUAL BACKGROUND

Brandy Kearney Chambers resigned from the Oklahoma Bar Association in 2014 and continued practicing law in Texas. She petitioned for reinstatement in Oklahoma in May 2025. Following a Professional Responsibility Tribunal hearing and review of joint exhibits, the tribunal recommended that she be reinstated. The Supreme Court found that she satisfied the procedural, competency, unauthorized-practice, and good-moral-character requirements.

PROCEDURAL HISTORY

Chambers resigned her membership in the Oklahoma Bar Association on February 14, 2014, and petitioned the Oklahoma Supreme Court for reinstatement on May 29, 2025. The Professional Responsibility Tribunal held a hearing on August 28, 2025, and recommended reinstatement. The Supreme Court granted the petition, conditioned on payment of costs, continuing legal education compliance, and payment of 2026 bar dues.

IN THE MATTER OF THE REINSTATEMENT OF BRANDY KEARNEY CHAMBERS ORDER ¶ 1 On February 14, 2014, the petitioner, Brandy Kearney Chambers, elected to resign her membership with the Oklahoma Bar Association. Since resigning with the OBA, Chambers has continued to practice law in the State of Texas (Texas Bar License No. 24041169).

On May 29, 2025, Chambers petitioned this Court for reinstatement. ¶ 2 A hearing was held before the Professional Responsibility Tribunal on August 28, 2025. After taking the testimony of witnesses and reviewing the submission of joint exhibits, the panel recommended that Chambers be reinstated to Active Member status. Upon consideration of the matter, we find: 1) The attorney has met all the procedural requirements necessary for reinstatement in the Oklahoma Bar Association as set out in Rules 11, Rules Governing Disciplinary Proceedings, 5 O.S.

2021, ch.1, app. 1-A. 2) The attorney has established, by clear and convincing evidence, that she has not engaged in the unauthorized practice of law in the State of Oklahoma or any other state. 3) The attorney has established, by clear and convincing evidence, that she possesses the competency and learning in the law required for reinstatement to the Oklahoma Bar Association.

4) The attorney has established, by clear and convincing evidence, that she possesses the good moral character which would entitle her to be reinstated to the Oklahoma Bar Association. ¶ 3 IT IS THEREFORE ORDERED that the petition of Brandy Kearney Chambers for reinstatement to the Oklahoma Bar Association should be granted, effective January 1, 2026. ¶ 4 According to the Application to Assess Costs, the OBA expended a total of \$972.80 during the handling of this reinstatement proceeding.

After reviewing the application, the Court finds the same should be approved and Petitioner Chambers is ordered to pay the sum of \$972.80 within sixty (60) days of this order. ¶ 5 IT IS FURTHER ORDERED that Petitioner is required to complete accredited continuing legal education each calendar year and report the same in compliance with Rules for Mandatory Continuing Legal Education, 5 O.S.2021, Ch. 1, App.

1-B. ¶ 6 Petitioner is further directed to pay bar dues for calendar year 2026 in the amount of \$350.00. ¶ 7 DONE BY ORDER OF THE SUPREME COURT THE 8 DAY OF December, 2025.
