SUMMARY

The Armed Services Board of Contract Appeals dismissed with prejudice the appeals of Desbuild Incorporated after the parties reported that the dispute had been settled. The order concerns ASBCA Nos. 64124 and 64126 under Contract No. N69450-16-D-1111.
