MEMORANDUM OPINION

Appellant Osama Gendra filed a notice of appeal from the trial court’s final judgment. We abated the appeal and referred the parties to mediation. On January 3, 2024, the parties filed a letter stating that the “case settled during mediation.” We construe the parties’ letter as a joint motion to dismiss. On March 27, 2026, appellees Damion Haskett and Belinda McMiller filed a motion to reinstate and dismiss the appeal asserting that “the parties reached a settlement of all outstanding issues” and requesting that we “dismiss this proceeding.” We reinstate the appeal and grant the motions to dismiss. See TEX. R. APP. P. 42.1(a)(1), 43.2(f). We dismiss any other pending motions as moot.
