The Hawai‘i Supreme Court amended and rejected Jin Quan Yang’s application for a writ of certiorari in Pacific Hawaii Food Service LLC v. Yang. The amendment corrected the application’s filing date from March 23, 2026, to April 1, 2026.

FACTUAL BACKGROUND

The opinion provides no substantive factual background concerning the underlying dispute. It addresses only the filing and rejection of the application for writ of certiorari.

PROCEDURAL HISTORY

The matter arose from a case in the Circuit Court of the Second Circuit and proceeded to the Intermediate Court of Appeals under CAAP-XX-XXXXXXX. Jin Quan Yang filed an application for writ of certiorari in the Hawai‘i Supreme Court on April 1, 2026. The Supreme Court rejected the application and amended an earlier April 29, 2026 order solely to correct the application's filing date.
