# Aerogrow International, Inc. v. District Court (Radoff)

### SUMMARY

The Supreme Court of Nevada granted Aerogrow International, Inc.'s petition for a writ of mandamus challenging the Eighth Judicial District Court's order granting a joint motion to compel. The court issued the writ and later denied petitions for rehearing and en banc reconsideration.

### PROCEDURAL HISTORY

Aerogrow filed a petition for a writ of mandamus and an emergency motion for expedited review and a stay of the district court's order. The Nevada Supreme Court temporarily stayed the order, then granted a continuing

stay, submitted the matter without oral argument, granted the petition, and issued the writ. Rehearing and en banc reconsideration were later denied.
