Alejandro Gonzalez v. F21 Opco LLC

Gonzalez v. F21 Opco LLC · No. CV 25-01909-SK · Decided June 11, 2025

SUMMARY

The court ordered Plaintiff Alejandro Gonzalez to show cause by June 25, 2025 why the action against F21 Opco LLC should not be dismissed without prejudice for lack of prosecution. The order states that Plaintiff had not filed proof of service within 90 days of filing the complaint and cites Federal Rule of Civil Procedure 4(m) and Link v. Wabash Railroad Co.

QUESTIONS PRESENTED

- Whether the court should require Plaintiff to show cause why the action should not be dismissed for lack of prosecution based on the failure to file proof of service within 90 days.
- Whether the matter was appropriate for submission without oral argument under Federal Rule of Civil Procedure 78.

HOLDINGS

1. Because Plaintiff failed to file proof of service within 90 days after filing the complaint, the court ordered Plaintiff to show cause why the action should not be dismissed for lack of prosecution. Plaintiff could avoid dismissal by demonstrating timely service or good cause for the failure to serve.
2. The matter was appropriate for submission without oral argument.

KEY QUOTATIONS

“Absent a showing of good cause, an action must be dismissed without prejudice if the summons and complaint are not served on a Defendant within 90 days after the complaint is filed.”

“Failure to respond to this Order to Show Cause will be deemed consent to the dismissal of the action.”

FACTUAL BACKGROUND

Plaintiff filed a complaint against F21 Opco LLC but had not filed proof of service within 90 days after filing the complaint. The court ordered Plaintiff to show cause why the action should not be dismissed for lack of prosecution and allowed Plaintiff to respond by showing timely service or good cause for failing to serve Defendant.

PROCEDURAL HISTORY

Plaintiff filed a complaint against F21 Opco LLC. The court determined that Plaintiff had not filed proof of service within the 90-day period prescribed by Federal Rule of Civil Procedure 4(m), ordered Plaintiff to show cause by June 25, 2025, and stated that failure to respond would be deemed consent to dismissal.
