On March 27, the Chief Deputy Clerk issued a notice, sent by certified mail, to Francis directing her to show cause why this appeal should not be dismissed for her failure to file an opening brief. On April 14, the Chief Deputy Clerk re-sent the notice to show cause via first-class mail. A timely response to the notice was due on or before April 27.
