QUESTIONS PRESENTED

1. Whether the court should grant appellant a 30-day extension of time to file the reporter's record.

FACTUAL BACKGROUND

The reporter's record in the criminal appeal was due on May 11, 2015. The court reporter advised appellant that an additional 30 days was needed because of a recent software change affecting the equipment used during the trial-court proceeding. Appellant's attorney also stated that counsel had been occupied with back-to-back jury trials, the most recent ending May 22, 2015.

PROCEDURAL HISTORY

The appeal was taken from the District Court of Hays County, Texas, 22nd Judicial District, in trial court cause number CR-13-0430. The reporter's record was due May 11, 2015. Appellant sought a 30-day extension because the court reporter needed additional time following a software change and because appellant's attorney had been engaged in consecutive jury trials. The document bears an accepted filing stamp from the First Court of Appeals.
