Gordon v. Boyd

96 A.D.3d 719 (N.Y. App. Div. 2d Dep't 2012) · Decided June 6, 2012

SUMMARY

The New York Appellate Division, Second Department, affirmed an order granting the plaintiff leave to renew opposition to the defendants' motion to dismiss. Upon renewal, the court properly denied dismissal because the purported release did not conclusively refute the plaintiff's allegations that he did not sign it and because he sufficiently alleged grounds to set it aside.

QUESTIONS PRESENTED

1. Whether the Supreme Court providently exercised its discretion in granting plaintiff leave to renew opposition to defendants' motion based on law office failure.
2. Whether the release submitted by defendants conclusively established a defense warranting dismissal under CPLR 3211(a)(1).
3. Whether plaintiff sufficiently averred grounds to set aside the release, precluding dismissal under CPLR 3211(a)(5).

HOLDINGS

1. The Supreme Court did not improvidently exercise its discretion in granting plaintiff leave to renew opposition to defendants' motion based on law office failure.
2. Defendants were not entitled to dismissal under CPLR 3211(a)(1) because the release they submitted did not utterly refute plaintiff's factual allegations and conclusively establish a defense as a matter of law.
3. Defendants were not entitled to dismissal under CPLR 3211(a)(5) because plaintiff sufficiently averred grounds for setting aside the release.

KEY QUOTATIONS

“A motion for leave to renew pursuant to CPLR 2221 (e) “may, in the Supreme Court’s discretion, be based on facts known to the party seeking renewal at the time of the original motion,” but the movant must offer “a reasonable justification for the failure to present such facts on the original motion”” (720)

“Law office failure can be accepted as a reasonable excuse in the exercise of the court’s sound discretion” (720)

“the documentary evidence submitted by them failed to utterly refute the plaintiffs factual allegations and conclusively establish a defense as a matter of law” (720)

FACTUAL BACKGROUND

The plaintiff brought an action for personal injuries. Defendants sought dismissal based on documentary evidence, relying on a release allegedly signed by the plaintiff, and also invoked a defense under CPLR 3211(a)(5). Plaintiff asserted that he did not personally sign the release and that it was signed by someone without authority to act for him. Plaintiff's failure to present those facts on the original motion was attributed to law office failure.

PROCEDURAL HISTORY

The Supreme Court, Westchester County, initially granted defendants' motion under CPLR 3211(a)(1) and (5) and dismissed the complaint. It later granted plaintiff leave to renew based on law office failure, effectively vacated the earlier order, and denied defendants' dismissal motion upon renewal. The Appellate Division affirmed.
