SUMMARY

The Eighth District Court of Appeals ordered court reporter Luis Duran to file the reporter's record in this accelerated appeal by February 21, 2023. The court stated that no further extensions would be granted and warned that failure to comply could result in an order to appear and show cause why he should not be held in contempt.

QUESTIONS PRESENTED

1. Whether the appellate court should order the court reporter to file the overdue reporter's record in the accelerated appeal.

KEY QUOTATIONS

“Accordingly, we hereby ORDER court reporter Luis Duran to file the reporter’s record in No. 08-23-00030-CV on or before February 21, 2023.”

FACTUAL BACKGROUND

This order concerns the absence of the reporter's record in an accelerated appeal. The record was initially due December 29, 2022, was extended to January 17, 2023, and still had not been filed by February 14, 2023. The appellate court noted numerous unsuccessful attempts to contact the court reporter, Luis Duran, regarding the record.

PROCEDURAL HISTORY

The appeal was taken from the 285th District Court of Bexar County, Texas, in trial-court cause number 2022-CI-14895. The reporter's record was originally due December 29, 2022, and the Fourth Court of Appeals extended the deadline to January 17, 2023. Because no reporter's record had been filed despite repeated attempts to contact the court reporter, the Eighth District Court of Appeals ordered the court reporter to file the record by February 21, 2023.
