SUMMARY

The United States District Court for the District of Minnesota accepted a magistrate judge's Report and Recommendation after no party objected and the court found no clear error. The court dismissed Shelley Jane Mills's complaint without prejudice for failure to prosecute and directed that judgment be entered.

QUESTIONS PRESENTED

1. Whether the district court should accept an unobjected-to magistrate judge's Report and Recommendation after reviewing it for clear error.
2. Whether the complaint should be dismissed without prejudice for failure to prosecute.

HOLDINGS

1. When no party objects to a magistrate judge's Report and Recommendation, the district court reviews it for clear error.
2. The complaint was properly dismissed without prejudice for failure to prosecute.

KEY QUOTATIONS

“Plaintiff’s Complaint [ECF No. 1] is DISMISSED WITHOUT PREJUDICE for failure to prosecute.”

FACTUAL BACKGROUND

The plaintiff filed a complaint against Anoka County Jail, Sheila Larson, and Brad Wise. The matter was referred to Magistrate Judge Elizabeth Cowan Wright, who issued a Report and Recommendation. The district court dismissed the complaint without prejudice for failure to prosecute.

PROCEDURAL HISTORY

Magistrate Judge Elizabeth Cowan Wright issued a Report and Recommendation on October 28, 2025. Because no party objected, the district court reviewed the recommendation for clear error, found none, accepted it, and dismissed the complaint without prejudice for failure to prosecute.
