SUMMARY

The United States District Court for the Eastern District of Missouri orders Plaintiff El Haq Malak Bey to submit physically signed filings using his true legal name and to include his email address. The order directs compliance by April 24, 2026, and warns that noncompliant filings will be stricken under Federal Rule of Civil Procedure 11(a).

QUESTIONS PRESENTED

1. Whether the plaintiff's filings complied with Federal Rule of Civil Procedure 11(a)'s signature and contact-information requirements.
2. Whether the plaintiff must submit physically signed filings using his true legal name and provide his email address, subject to having the filings stricken for noncompliance.

HOLDINGS

1. The plaintiff's filings were not properly signed and did not comply with Rule 11(a)'s requirements concerning a physical signature and the signer's email address.
2. The plaintiff must physically sign his filings using his true legal name.
3. If the plaintiff fails to comply with the order, the court will strike his filings.

KEY QUOTATIONS

“If Plaintiff fails to comply with this Order, the Court “must” strike his filings.” (at 2)

“Plaintiff must “promptly” correct this error by submitting physically signed filings.” (at 2)

FACTUAL BACKGROUND

The court determined that none of the filings submitted in the matter was properly signed. The filings apparently used a name other than the plaintiff's true legal name and included an email address that did not satisfy the court's requirements. The court directed the plaintiff to correct these deficiencies by a specified deadline.

PROCEDURAL HISTORY

The plaintiff submitted filings that were not properly signed. The district court issued a memorandum and order requiring him to submit physically signed copies using his true legal name and to include his email address, warning that noncompliant filings would be stricken.

filings in this matter shows that none is properly signed. See *Pack v. City of St. Charles*, 4:25-cv-0911-MTS, 2025 WL 2549230, at *1 (E.D.

Mo. Sept. 4, 2025); *McGehee v. Synchrony Bank*, 4:25-cv-0933-MTS, 2025 WL 1993555, at *1 (E.D. Mo. July 17, 2025). Plaintiff must “promptly” correct this error by submitting physically signed filings. Fed. R. Civ. P. 11(a). They must be physically signed with his true legal name. See *Harris Est. v. City of Florissant*, 4:25-cv-0968-MTS, 2025 WL 2821262, at *1 (E.D.

Mo. Oct. 3, 2025); Fed. R. Civ. P. 17(a)(1). In addition, Plaintiff must comply with Rule 11(a) by providing his email address on his filings. Compare Rule 11(a) (“The paper must state the signer’s address, e-mail address, and telephone number.”), with Doc.

[1] at 50 (“Email: ”). If Plaintiff fails to comply with this Order, the Court “must” strike his filings. Fed. R. Civ. P. 11(a). Accordingly, IT IS HEREBY ORDERED that no later than Friday, April 24, 2026, Plaintiff must comply with this Memorandum and Order by submitting physically signed copies of his filings in his true legal name. Plaintiffs filings must also provide his email address.

If Plaintiff fails to do so, the Court will strike Plaintiff's filings. Dated this 15th day of April 2026.
