Solid Income Limited v. EnergyInvest LLC

SUMMARY

The United States District Court for the Northern District of California denied administrative motions to relate two December 2024 civil actions to earlier-filed miscellaneous judgment-enforcement proceedings. The court held that the motions were more appropriately directed to the judges handling the earlier-filed matters and denied them without prejudice.

QUESTIONS PRESENTED

1. Whether the Solid Income–EnergyInvest action should be related to an earlier-filed miscellaneous judgment-enforcement action under Civil Local Rule 3-12.
2. Whether the motion to relate should be directed to the judge handling the earlier-filed matter.

HOLDINGS

1. The motion to relate was denied without prejudice because the earlier-filed miscellaneous judgment-enforcement action was already pending in the district when the present case was filed, making it more appropriate for the motion to be directed to the judge handling the earlier case.

FACTUAL BACKGROUND

Solid Income Limited’s action against EnergyInvest LLC and a separate action involving American HomeEnergy LLC were filed on December 26, 2024. EnergyInvest sought to relate the Solid Income–EnergyInvest case to an earlier miscellaneous action filed on September 6, 2024, concerning enforcement of a federal default judgment entered in New York. The earlier action was pending before Magistrate Judge Sallie Kim, while the present action was before Judge Gilliam.

PROCEDURAL HISTORY

Solid Income Limited filed this action against EnergyInvest LLC on December 26, 2024. EnergyInvest moved to relate this case to an earlier miscellaneous action seeking enforcement of a federal default judgment, filed on September 6, 2024, before Magistrate Judge Sallie Kim. The court denied the motion without prejudice, concluding that any relatedness request should be directed to the judge handling the earlier-filed matter.
