SUMMARY

The United States District Court for the Eastern District of California adopts the magistrate judge’s findings and recommendations in a prisoner civil rights action under 42 U.S.C. § 1983. Because the plaintiff did not object, the court dismisses the action without prejudice under Federal Rule of Civil Procedure 41(b).

QUESTIONS PRESENTED

- Whether the district court should adopt the magistrate judge's findings and recommendations when plaintiff did not file objections after being properly served.

2. Whether the action should be dismissed without prejudice under Federal Rule of Civil Procedure 41(b) and Local Rule 110.

HOLDINGS

1. The district court adopted the magistrate judge's findings and recommendations in full because they were supported by the record and proper analysis, and plaintiff filed no objections.
2. The action was dismissed without prejudice.

FACTUAL BACKGROUND

Plaintiff was a state prisoner proceeding without counsel who brought a civil rights action seeking relief under 42 U.S.C. § 1983. The findings and recommendations were served on plaintiff at his updated address, but he did not file objections within the applicable period.

PROCEDURAL HISTORY

Michael Littleton, a state prisoner proceeding pro se, filed this civil rights action under 42 U.S.C. § 1983. The matter was referred to a magistrate judge, who issued findings and recommendations on December 1, 2022. After the findings and recommendations were served at plaintiff's updated address, plaintiff filed no objections. The district court adopted the findings and recommendations in full and dismissed the action without prejudice.
