People of the State of Michigan v. Justly Ernest Johnson

SUMMARY

The Michigan Supreme Court granted the defendant's motion to withdraw his application for leave to appeal and dismissed the case with prejudice. This procedural order resolves the appeal without reaching the merits of any underlying criminal conviction or legal issue.
