SUMMARY

This document comprises the execution order, death warrant, officer's return, and Texas Department of Criminal Justice director's return and certificate concerning Lester Leroy Bower, Jr. The documents record that Bower's death sentence was carried out by lethal injection at the Huntsville Unit on June 3, 2015, following state and federal post-conviction proceedings. The certificate states that the remains were released to a funeral home agent for a requesting relative.

FACTUAL BACKGROUND

Bower was convicted of capital murder in four Grayson County causes and received a death sentence on May 7, 1984. Following direct affirmance and multiple denials of state and federal collateral relief, the Grayson County district court issued an order and death warrant directing that the sentence be carried out on June 3, 2015. The Texas Department of Criminal Justice reported that the execution was completed by intravenous injection at the Huntsville Unit.

PROCEDURAL HISTORY

Lester Leroy Bower, Jr. was convicted of capital murder and sentenced to death in the 15th District Court of Grayson County on May 7, 1984. The Texas Court of Criminal Appeals affirmed the convictions in 1989 and denied state habeas relief in 1992 and again in 2014. After the United States Supreme Court denied certiorari and the stay of execution was lifted, the district court set the execution for June 3, 2015. The execution was carried out on that date, and the director filed the required return and certificate.
