Hernandez v. Schultz

SUMMARY

The United States District Court for the Eastern District of California adopted the magistrate judge’s findings and recommendations and denied Victor Alfonso Hernandez’s petition for a writ of habeas corpus under 28 U.S.C. § 2254. The court denied the petition with prejudice, declined to issue a certificate of appealability, and directed the clerk to enter judgment and close the case.

QUESTIONS PRESENTED

1. Whether the magistrate judge's findings and recommendations recommending denial of the § 2254 petition should be adopted after de novo review of petitioner's objections.
2. Whether a certificate of appealability should issue following denial of the habeas petition on the merits.

HOLDINGS

1. The findings and recommendations were supported by the record and proper analysis, and petitioner's objections did not identify an error requiring rejection; therefore, the findings and recommendations were adopted in full and the habeas petition was denied with prejudice.
2. A certificate of appealability should not issue because reasonable jurists would not find the denial of the petition debatable or wrong and petitioner did not make the required substantial showing of the denial of a constitutional right.

- “reasonable jurists would not find the Court’s determination that the petition should be denied debatable or wrong, or that the issues presented are deserving of encouragement to proceed further.”* (at 2)

FACTUAL BACKGROUND

Victor Alfonso Hernandez is a state prisoner who filed a petition for a writ of habeas corpus under 28 U.S.C. § 2254. The opinion does not summarize the underlying conviction or the specific constitutional claims because it adopts the magistrate judge's merits analysis. The district court concluded that the petition was not supported by grounds warranting habeas relief.

PROCEDURAL HISTORY

The magistrate judge issued findings and recommendations on October 31, 2024, recommending that the habeas petition be denied on its merits. Petitioner filed objections on November 21, 2024. The district court reviewed the matter de novo, adopted the findings and recommendations in full, denied the petition with prejudice, declined to issue a certificate of appealability, and directed entry of judgment and closure of the case.
