SUMMARY

This is an en banc per curiam opinion of the Supreme Court of Nevada in a civil appeal involving Resources Group, LLC, Nevada Association Services, Inc., and Hydr-O-Dynamic Corporation. The court reversed and remanded the lower-court decision; the opinion was issued on March 14, 2019, and remittitur followed on April 9, 2019.
