SUMMARY

The Sixth Court of Appeals of Texas affirmed the trial court’s orders dismissing claims against Dr. Mark Campbell, Dr. Mark Gibbs and Paris Orthopedic Clinic, P.A., and Dr. Pia Lippincott. The court ordered Angela Hilton, individually and as representative of Barbara Jackson’s estate, to pay the costs of the appeal.
