Matter of Zwillman

SUMMARY

The Appellate Division, Third Department granted Blair Robin Zwillman's application to resign from the New York bar for nondisciplinary reasons. The court accepted the resignation, struck his name from the roll of attorneys effective immediately, prohibited him from practicing law in New York, and ordered him to surrender any Attorney Secure Pass within 30 days.

QUESTIONS PRESENTED

1. Whether Blair Robin Zwillman was eligible to resign from the New York bar for nondisciplinary reasons under 22 NYCRR 1240.22(a).
2. Whether the court should grant the application, accept the resignation, strike Zwillman's name from the roll of attorneys, and prohibit him from practicing law in New York.

HOLDINGS

1. An attorney who satisfies the requirements for nondisciplinary resignation under 22 NYCRR 1240.22(a) may be permitted to resign from the New York bar, and Zwillman was eligible to do so.
2. Upon acceptance of the nondisciplinary resignation, the attorney's name is stricken from the roll, the attorney must desist from practicing law or holding himself out as an attorney in New York, and any Attorney Secure Pass must be surrendered within 30 days.

FACTUAL BACKGROUND

Blair Robin Zwillman was admitted to practice by the Appellate Division, Third Department, in 1983 and maintained a business address in Morristown, New Jersey. He sought permission to resign from the New York bar for nondisciplinary reasons. The Attorney Grievance Committee for the Third Judicial Department advised that it did not oppose the application.

PROCEDURAL HISTORY

Blair Robin Zwillman, admitted to practice in New York in 1983, submitted an affidavit seeking permission to resign for nondisciplinary reasons. After reviewing the affidavit and the Attorney Grievance Committee's response, the Appellate Division determined that he was eligible and granted the application.

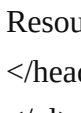

Upon reading Zwillman's affidavit sworn to March 28, 2026 and filed April 13, 2026, and upon reading the April 28, 2026 correspondence in response by the Deputy Chief Attorney for AGC, and having determined that Zwillman is eligible to resign for nondisciplinary reasons, we grant his application and accept his resignation.

ORDERED that Blair Robin Zwillman is commanded to desist and refrain from the practice of law in any form in the State of New York, either as principal or as agent, clerk or employee of another; and Zwillman is hereby forbidden to appear as an attorney or counselor-at-law before any court, judge, justice, board, commission or other public authority, or to give to another an opinion as to the law or its application, or any advice in relation thereto, or to hold himself out in any way as an attorney and counselor-at-law in this State; and it is further

ORDERED that Blair Robin Zwillman shall, within 30 days of the date of this decision, surrender to the Office of Court Administration any Attorney Secure Pass issued to him.
