Brown*, 310 So. 3d 1046, 1048-49 (Fla. 5th DCA 2020) (the defendant’s “consent to separate trials obviated any double jeopardy or collateral estoppel concerns,” and neither *Burr v. State*, 576 So. 2d 278 (Fla.

1991) nor *State v. Perkins*, 349 So. 2d 161 (Fla. 1977) stand “for the proposition that a separate Florida due process right bars the State from referencing [the defendant’s] firearm possession [addressed in an initial possession of firearm trial] during a second trial” addressing the other charges arising from the same incident).
