- Whether the magistrate judge’s findings and recommendations should be adopted after review of plaintiffs’ objections.

2. Whether the action should be dismissed as duplicative and for failure to comply with court orders.

HOLDINGS

1. The district court adopted the magistrate judge's findings and recommendations in full after considering plaintiffs' objections.
2. The action was dismissed as duplicative and for failure to comply with court orders.

FACTUAL BACKGROUND

The opinion provides no substantive facts concerning the underlying dispute. The case was dismissed because it was duplicative and because plaintiffs failed to comply with court orders.

PROCEDURAL HISTORY

On May 7, 2025, the magistrate judge issued findings and recommendations recommending disposition of the action. Plaintiffs filed objections within the permitted period. The district court reviewed the objections, presumed the magistrate judge's factual findings correct, reviewed legal conclusions de novo, adopted the findings and recommendations in full, dismissed the action as duplicative and for failure to comply with court orders, and directed the Clerk to close the case.
