Allen Alexander Parks v. Mark Knutson, et al.

SUMMARY

The United States District Court for the Western District of Oklahoma construes Plaintiff Allen Alexander Parks’s notice as a voluntary dismissal under Federal Rule of Civil Procedure 41(a)(1)(A)(i). The court explains that the dismissal was self-executing, directs the Clerk to terminate the action as of the notice date, and vacates the referral order to the magistrate judge.

ORDER

On April 9, 2026, the Clerk received Plaintiff’s “Notice of Voluntary Dismissal of This CIV-25-1564-D Case Without Prejudice” [Doc. No. 17], which the Court construes as a notice of dismissal pursuant to FED. R. CIV. P. 41(a)(1)(A)(i). So construed, Plaintiff’s request operates as a notice of voluntary dismissal of this case without further action by the Court.¹ IT IS THEREFORE ORDERED that the Clerk is directed to terminate this action in her records as of the date of Plaintiff’s notice of voluntary dismissal.² ¹ See *De Leon v. Marcos*, 659 F.3d 1276, 1283 (10th Cir. 2011) (“stipulation of dismissal filed under Rule 41(a)(1)(A)(i) or (ii) is self-executing”); *Janssen v. Harris*, 321 F.3d 998, 1000 (10th Cir. 2003) (pro se plaintiff’s “clear statement” that he wants his action dismissed effectuates a dismissal under Rule 41(a)(1)(A)(i); “no action is required on the part of the court”); see also *Netwig v. Ga. Pac. Corp.*, 375 F.3d 1009, 1010 (10th Cir. 2004) (dismissal was effective on date of Rule 41(a)(1) filing). ² When processing Plaintiff’s initial filing, the Clerk entered an order of referral to United States Magistrate Judge Chris M. Stephens under 28 U.S.C. § 636. That Order [Doc. No. 4] is VACATED. IT IS SO ORDERED this 10th day of April, 2026. □□ Q.QyPt
