Cody R. Roberson v. Commissioner, Social Security Administration

SUMMARY

The United States District Court for the Eastern District of Texas adopts the magistrate judge’s report and recommendation in a Social Security appeal. The court rejects the plaintiff’s objections concerning the administrative law judge’s residual functional capacity assessment, affirms the Commissioner’s final decision, and dismisses the case with prejudice.

DISPOSITION	affirmed
PROCEDURAL POSTURE	Plaintiff sought judicial review of the Commissioner of Social Security's final decision. After the magistrate judge recommended affirmance and dismissal with prejudice, plaintiff filed objections, which the district court reviewed de novo.
STANDARD OF REVIEW	The court reviewed the objected-to portions of the Report and Recommendation de novo. Judicial review of the Commissioner's decision was limited to determining whether it was supported by substantial evidence and whether the proper legal standards were applied. The court did not reweigh the evidence, try the issues de novo, or substitute its judgment for the Commissioner's.

QUESTIONS PRESENTED

1. Whether the ALJ's residual functional capacity assessment was supported by substantial evidence and explained adequately.
2. Whether the ALJ was required to adopt a specific physician's assessment when determining residual functional capacity.
3. Whether the ALJ was required to make a specific finding that Roberson could work on a regular and continuing basis.
4. Whether the ALJ or magistrate judge improperly relied on a middle-ground rationale because the RFC was more restrictive than some opinions and less restrictive than others.

HOLDINGS

1. The ALJ's RFC finding was supported by substantial evidence and the ALJ applied the correct legal standards.
2. The ALJ was not required to adopt a specific physician's assessment in determining the claimant's RFC.
3. A specific finding that the claimant can perform work on a regular and continuing basis is not required absent special circumstances.
4. There was no error in finding that the ALJ's RFC was less limiting than some medical opinions and more limiting than others.

FACTUAL BACKGROUND

Roberson challenged the Commissioner's final Social Security decision, focusing on the ALJ's assessment of his residual functional capacity. He contended that the ALJ failed to explain how the evidence supported the specific limitations, improperly relied on a middle-ground rationale, failed to account for the combined effects of his

impairments, and improperly rejected certain medical opinions. The district court found that the ALJ provided detailed explanations addressing the medical opinions, objective evidence, subjective symptoms, and mental impairments, and that the RFC finding was supported by substantial evidence.

PROCEDURAL HISTORY

The case was referred to Magistrate Judge K. Nicole Mitchell under 28 U.S.C. § 636. On February 23, 2026, the magistrate judge issued a Report and Recommendation recommending that the court affirm the Commissioner's final decision and dismiss the appeal with prejudice. Plaintiff objected, principally challenging the ALJ's residual functional capacity assessment. The district court conducted de novo review, adopted the Report and Recommendation, affirmed the Commissioner's decision, and dismissed the case with prejudice.

DISPOSITION
