Matter of Miguel C. v. Bennie B.

SUMMARY

The New York Appellate Division, First Department unanimously affirmed an order denying the father's violation petition and permitting the mother to relocate with the children to Georgia. The court held that the father did not establish a willful violation of the custody order and that the relocation was supported by the children's best interests, while also finding no abuse of discretion in declining to conduct in camera interviews.

PROCEDURAL POSTURE	Father appealed from an order of Supreme Court, New York County, Integrated Domestic Violence Part, that denied his violation petition against the mother and granted the mother's modification petition permitting her to relocate with the children to Georgia.
STANDARD OF REVIEW	The court would not disturb the lower court's credibility determination absent a basis to do so; the relocation determination was upheld because it had a sound and substantial basis in the record; and the determination not to conduct in camera interviews was reviewed for abuse of discretion.

QUESTIONS PRESENTED

1. Whether the father established by clear and convincing evidence that the mother willfully violated the prior custody order in a manner that prejudiced him.
2. Whether the mother established by a preponderance of the evidence that relocating with the children to Georgia was in their best interests.
3. Whether the lower court abused its discretion by declining to conduct in camera interviews with the children.
4. Whether the father abandoned any appeal from the denial of his own modification petition by failing to address that ruling in his appellate brief.

HOLDINGS

1. The violation petition was properly denied because the father failed to prove by clear and convincing evidence that the mother willfully violated the prior custody order in a manner that prejudiced him.
2. The mother's modification petition was properly granted because she established by a preponderance of the evidence that the children's relocation to Georgia with her was in their best interests.
3. The father failed to demonstrate that Family Court abused its discretion by declining to conduct in camera interviews with the children.
4. The father abandoned any appeal from the denial of his modification petition seeking joint custody by failing to address that ruling in his appellate brief.

FACTUAL BACKGROUND

The mother notified the father of her intention to move to Georgia with the children, but the father did not respond or object. The mother was the children's primary caretaker, while the father did not contribute financially to their care and did not consistently visit them or make efforts to strengthen his relationship with them. The children were thriving in Georgia, where they enjoyed their school, friends and nearby family, their own bedrooms, and outdoor space.

PROCEDURAL HISTORY

The Integrated Domestic Violence Part denied the father's petition alleging that the mother violated a prior custody order and granted the mother's petition to modify custody to permit relocation with the children. The Appellate Division, First Department, unanimously affirmed the order without costs.
