FACTUAL BACKGROUND

The opinion concerns a civil-rights employment-discrimination action brought by Soma Peterson against One Community Health. The court's order addresses the defendant's motion for summary judgment and the plaintiff's objections to the magistrate judge's recommendation that the motion be granted. The order does not recite additional material underlying facts because it adopts the Findings and Recommendation without modification.

PROCEDURAL HISTORY

Magistrate Judge Youlee Yim You issued Findings and Recommendation on February 17, 2026, recommending that One Community Health's motion for summary judgment be granted. Soma Peterson timely objected. The district court reviewed the challenged portions de novo, found no error, adopted the Findings and Recommendation, and granted the motion.
