This matter will stand submitted upon the filing of Plaintiff(s) response.

Failure to respond will be deemed consent to the dismissal of the action. ☒ Defendant(s) Princess Cruise Lines Ltd. did not answer the complaint, yet Plaintiff(s) have failed to request entry of default, pursuant to Fed. R. Civ. P. 55(a). Plaintiff(s) can satisfy this order by seeking entry of default or by dismissing the complaint. IT IS SO ORDERED.
