The Appellate Division, Second Department dismissed a writ of habeas corpus seeking release on recognizance or reasonable bail in connection with a Nassau County indictment. The court concluded that the lower court's determination did not violate constitutional or statutory standards.

FACTUAL BACKGROUND

Joseph L. Calixte, Jr. sought release on his own recognizance or, alternatively, reasonable bail in connection with Nassau County Indictment No. 70090/2017. The Appellate Division reviewed the Nassau County Supreme Court's determination and concluded that it did not violate applicable constitutional or statutory standards.

PROCEDURAL HISTORY

Calixte sought habeas relief in the Appellate Division to obtain release on his own recognizance or reasonable bail. The court reviewed the determination of the Supreme Court, Nassau County, and dismissed the writ without costs or disbursements.

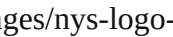
