# Progressive Gulf Insurance Co. v. Faehnrich

### SUMMARY

The Nevada Supreme Court, sitting en banc, issued an authored opinion answering a certified question from the United States Court of Appeals for the Ninth Circuit in *Progressive Gulf Insurance Co. v. Faehnrich*. The opinion was filed on March 27, 2014, and the case was subsequently closed after issuance of a notice in lieu of remittitur.
