SUMMARY

The United States District Court for the Eastern District of Pennsylvania partially granted and partially denied Plaintiff's motion for attorney's fees under 42 U.S.C. § 406(b). The court awarded Joshua B. Goldberg \$16,500 in fees and ordered him to remit \$3,000 to the plaintiff for fees previously paid under the Equal Access to Justice Act.

QUESTIONS PRESENTED

- Whether Plaintiff's counsel should be awarded attorney's fees under 42 U.S.C. § 406(b), and in what amount.

2. Whether counsel receiving a § 406(b) award must remit to Plaintiff fees previously paid under the Equal Access to Justice Act.

HOLDINGS

1. Plaintiff's counsel is entitled to an attorney's-fee award under 42 U.S.C. § 406(b) in the amount of \$16,500.00.
2. Upon receiving the § 406(b) award, counsel must directly remit \$3,000.00 to Plaintiff, representing fees previously paid to counsel's firm under the Equal Access to Justice Act.

FACTUAL BACKGROUND

Plaintiff's counsel, Joshua B. Goldberg, sought attorney's fees pursuant to 42 U.S.C. § 406(b). Counsel had already received \$3,000.00 in fees under the Equal Access to Justice Act. The court awarded \$16,500.00 under § 406(b) and ordered counsel to remit the previously paid \$3,000.00 to Plaintiff.

PROCEDURAL HISTORY

After proceedings in this Social Security matter, Plaintiff sought an award of attorney's fees under 42 U.S.C. § 406(b). The court granted the motion in part and denied it in part, awarding Plaintiff's counsel \$16,500.00 and directing counsel to remit \$3,000.00 to Plaintiff for fees previously paid under the Equal Access to Justice Act.
