SUMMARY

The Hawai‘i Intermediate Court of Appeals issued an Order of Correction concerning its June 6, 2025 opinion in the interest of J.B. The order directs corrections to quotation marks, underlining, and a glottal stop symbol in the opinion and instructs the clerk to notify publishing agencies.

FACTUAL BACKGROUND

The correction order does not describe the underlying facts. It identifies corrections to quotation punctuation, an underline, and a typographical symbol in the court's prior opinion.

PROCEDURAL HISTORY

The matter arose from an appeal from the Family Court of the First Circuit under FC-J No. 0115174. On December 29, 2025, the Intermediate Court of Appeals issued an order correcting typographical and formatting errors in its June 6, 2025 opinion and directed the clerk to notify publishing agencies.
