WOW TECH USA, LTD. v. EIS, INC.

SUMMARY

The United States District Court for the District of Delaware denied WOW Tech USA, Ltd.’s motion for leave to file its Third Amended Complaint under seal. The court held that Plaintiff failed to show that the third-party witness names were protectable information or that disclosure would cause a clearly defined and serious injury, and ordered the complaint unsealed immediately.

QUESTIONS PRESENTED

1. Whether Plaintiff met its burden to seal the names of third-party witnesses in its third amended complaint and exhibits.
2. Whether the court's prior unopposed order allowing the second amended complaint to be filed under seal established that the third amended complaint should also remain sealed.

HOLDINGS

1. Plaintiff failed to meet its burden to show both that the witness names were information courts will protect and that disclosure would cause a clearly defined and serious injury; therefore, the motion to file the third amended complaint under seal was denied.
2. The prior order did not establish that the third amended complaint should be sealed because the court made no factual findings when it summarily granted the earlier, apparently unopposed motion.

FACTUAL BACKGROUND

Plaintiff sought to seal the names of third-party witnesses in its third amended complaint and accompanying exhibits, designating the names as attorneys-eyes-only. Plaintiff asserted, without substantiation, that disclosure could create a substantial risk of intimidation, harassment, or business retaliation. The court observed that the witnesses were likely to be subpoenaed and deposed and had not shown extraordinary circumstances warranting anonymity.

PROCEDURAL HISTORY

Plaintiff previously filed its second amended complaint under seal after the court summarily granted an apparently unopposed sealing motion. Plaintiff then sought leave to file its third amended complaint under seal, and Defendant opposed the request. The district court denied the motion because Plaintiff failed to establish both that the information was entitled to protection and that disclosure would cause a clearly defined and serious injury.
