SUMMARY

The United States District Court for the District of South Carolina adopted the magistrate judge’s Report and Recommendation and dismissed Mario Donye Gullette’s action without prejudice and without leave for further amendment. The court noted that Gullette filed no objections to the Report and advised him of his right to appeal within thirty days.

QUESTIONS PRESENTED

1. What standard of review applies when a party fails to object to a magistrate judge's Report and Recommendation?
2. Whether the court should adopt the Report and Recommendation and dismiss the action without prejudice and without leave for further amendment.

HOLDINGS

1. When a party fails to file a timely objection to a magistrate judge's Report and Recommendation, the district court need not conduct de novo review and may accept the recommendation after determining that no clear error appears on the face of the record.
2. A party's failure to object to a magistrate judge's Report and Recommendation waives appellate review of the issues addressed in the recommendation.
3. The court adopted and incorporated the Report and Recommendation and dismissed the action without prejudice and without leave for further amendment.

“The Court is charged with making a de novo determination of those portions of the Report to which specific objection is made, and the Court may accept, reject, or modify, in whole or in part, the recommendation of the Magistrate Judge or recommit the matter with instructions.”

“It is therefore the judgment of the Court this matter is DISMISSED WITHOUT PREJUDICE and without leave for further amendment.”

FACTUAL BACKGROUND

Mario Donye Gullette, proceeding without counsel, filed a lawsuit against Cynthia Hamilton, Officer Mrs. Hamilton, Fredrick Davis, Heather Burdett, and Anthony Breedon. The opinion does not set out the underlying factual allegations because the district court adopted the magistrate judge's Report and Recommendation and dismissed the action on review of that recommendation.

PROCEDURAL HISTORY

Plaintiff filed this civil action against five defendants. A magistrate judge issued a Report and Recommendation on March 26, 2026, recommending summary dismissal without leave for further amendment. Plaintiff did not object. The district court reviewed the Report and record for clear error, adopted and incorporated the Report, and dismissed the matter without prejudice and without leave for further amendment.
