SUMMARY

The Appellate Division, Third Department granted Harry Aaron Horwitz's application to resign from the New York bar for nondisciplinary reasons. The court accepted his resignation, struck his name from the roll of attorneys effective immediately, prohibited him from practicing law in New York, and ordered him to surrender any Attorney Secure Pass within 30 days.

Horwitz now seeks leave to resign from the New York bar for nondisciplinary reasons (see Rules for Atty Disciplinary Matters [22 NYCRR] § 1240.22 [a]). The Attorney Grievance Committee for the Third Judicial Department (hereinafter AGC) advises that it does not oppose Horwitz's application. Upon reading Horwitz's affidavit sworn to April 28, 2026 and filed April 30, 2026, and upon reading the May 7, 2026 correspondence in response by the Deputy Chief Attorney for

AGC, and having determined that Horwitz is eligible to resign for nondisciplinary reasons, we grant his application and accept his resignation.

Pritzker, J.P., Ceresia, Powers, Mackey and Ryba, JJ., concur. ORDERED that Harry Aaron Horwitz's application for permission to resign is granted and his nondisciplinary resignation is accepted; and it is further ORDERED that Harry Aaron Horwitz's name is hereby stricken from the roll of attorneys and counselors-at-law of the State of New York, effective immediately, and until further order of this Court (see generally Rules for Atty Disciplinary Matters [22 NYCRR] § 1240.22 [b]); and it is further ORDERED that Harry Aaron Horwitz is commanded to desist and refrain from the practice of law in any form in the State of New York, either as principal or as agent, clerk or employee of another; and Horwitz is hereby forbidden to appear as an attorney or counselor-at-law before any court, judge, justice, board, commission or other public authority, or to give to another an opinion as to the law or its application, or any advice in relation thereto, or to hold himself out in any way as an attorney and counselor-at-law in this State; and it is further ORDERED that Harry Aaron Horwitz shall, within 30 days of the date of this decision, surrender to the Office of Court Administration any Attorney Secure Pass issued to him.
