SUMMARY

The United States District Court for the Eastern District of California transferred a pro se prisoner's civil rights action to the Central District of California because the claims arose from events at California State Prison in Lancaster and the defendants appeared to reside there. The court ordered the clerk to close the action in the Eastern District of California.

1. Whether venue was proper in the Eastern District of California when the alleged events occurred and the defendants appeared to reside in the Central District of California.

2. Whether the court should transfer the action to the Central District of California rather than dismiss it.

HOLDINGS

1. Venue was improper in the Eastern District of California because the claims arose from events in Los Angeles County and the defendants appeared to reside in the Central District of California.
2. The action should be transferred to the Central District of California in the interest of justice rather than dismissed.

FACTUAL BACKGROUND

Plaintiff Hector Martin Prieto, a state prisoner proceeding pro se, filed a civil-rights action under 42 U.S.C. § 1983. The complaint concerned events at California State Prison in Lancaster, Los Angeles County, which lies within the Central District of California. The defendants were employed at that facility and appeared to reside in the Central District.

PROCEDURAL HISTORY

Plaintiff filed the action and a motion to proceed in forma pauperis on May 27, 2025. The in forma pauperis motion was granted on May 28, 2025. After reviewing the complaint, the court found that the claims arose from events at a facility in Los Angeles County and transferred the matter to the Central District of California in the interest of justice, directing the clerk to close the Eastern District action.
