SUMMARY

The United States District Court for the Western District of Arkansas adopted a magistrate judge's Report and Recommendation concluding that the Administrative Law Judge's denial of Social Security benefits was not supported by substantial evidence. The court reversed the Commissioner's decision and remanded the case for further proceedings under Sentence Four of 42 U.S.C. § 405(g).

QUESTIONS PRESENTED

1. Whether the court should adopt the magistrate judge's Report and Recommendation in the absence of objections and upon finding no clear error.
2. Whether the Commissioner's denial of Social Security benefits should be reversed because the ALJ's decision was not supported by substantial evidence.
3. Whether the case should be remanded to the Commissioner under Sentence Four of 42 U.S.C. § 405(g).

HOLDINGS

1. The court adopted the magistrate judge's Report and Recommendation in toto after finding no clear error on the face of the record and concluding that the magistrate judge's reasoning was sound.
2. The Commissioner's decision denying benefits was reversed because the ALJ's decision was not supported by substantial evidence.
3. The matter was remanded to the Commissioner for further proceedings pursuant to Sentence Four of 42 U.S.C. § 405(g).

FACTUAL BACKGROUND

The Administrative Law Judge denied Bret Anthony's claim for Social Security benefits. The magistrate judge determined that the ALJ's denial was not supported by substantial evidence. The district court adopted that determination and remanded the matter to the Commissioner for further proceedings.

PROCEDURAL HISTORY

The Administrative Law Judge denied Plaintiff's application for benefits. Magistrate Judge Spencer G. Singleton concluded that the ALJ's decision was not supported by substantial evidence and recommended reversal and remand. No objections were filed, and the district court found no clear error, adopted the Report and Recommendation in full, reversed the Commissioner's decision, and remanded under Sentence Four of 42 U.S.C. § 405(g).
