Jesse Alberto Loor v. State of Florida

SUMMARY

The Third District Court of Appeal of Florida affirmed the summary denial of Jesse Alberto Loor's Florida Rule of Criminal Procedure 3.850 motion alleging ineffective assistance of counsel. The court concluded that the claims were either legally insufficient or conclusively refuted by the record.

Jesse Alberto Loor ("Loor") appeals the summary denial of his Rule 3.850 motion for post-conviction relief based on ineffective assistance of counsel.

We have jurisdiction. Fla. R. App. P. 9.140(b)(1)(D). Because Loor's claims were either legally insufficient or conclusively refuted by the record, we affirm. See *Maxwell v. State*, 937 So. 2d 216, 216 (Fla. 3d DCA 2006) ("The defendant appeals the trial court's summary denial of his motion for post conviction relief alleging ineffective assistance of trial counsel.

The defendant's claims are legally insufficient and conclusively refuted by the record."); *Franqui v. State*, 59 So. 3d 82, 96 (Fla. 2011) (recognizing that "mere conclusory allegations" are insufficient to state a claim under rule 3.850); *Rodriguez v. State*, 219 So. 3d 751, 756 (Fla. 2017) ("We affirm the summary denial below because Rodriguez's claims are conclusively refuted by the record.").
