Pritzker, J.P., Ceresia, Powers, Mackey and Ryba, JJ., concur. ORDERED that Marilyn Sanchez-Osorio's application for permission to resign is granted and her nondisciplinary resignation is accepted; and it is further ORDERED that Marilyn Sanchez-Osorio's name is hereby stricken from the roll of attorneys and counselors-at-law of the State of New York, effective immediately, and until further order of this Court (see generally Rules for Atty Disciplinary Matters [22 NYCRR] § 1240.22 [b]); and it is further ORDERED that Marilyn Sanchez-Osorio is commanded to desist and refrain from the practice of law in any form in the State of New York, either as principal or as agent, clerk or employee of another; and Sanchez-Osorio is hereby forbidden to appear as an attorney or

counselor-at-law before any court, judge, justice, board, commission or other public authority, or to give to another an opinion as to the law or its application, or any advice in relation thereto, or to hold herself out in any way as an attorney and counselor-at-law in this State; and it is further ORDERED that Marilyn Sanchez-Osorio shall, within 30 days of the date of this decision, surrender to the Office of Court Administration any Attorney Secure Pass issued to her. ORDERED that Marilyn Sanchez-Osorio shall, within 30 days of the date of this decision, surrender to the Office of Court Administration any Attorney Secure Pass issued to her.
