SUMMARY

****Michigan Supreme Court order (2020) granting motions by the Probate and Estate Planning Section and the Real Property Law Section of the State Bar of Michigan to file amicus curiae briefs in a real property and estate planning dispute.**** The underlying case, Schaaf v. Forbes, involves an appeal from Antrim County Circuit Court (No. 2016-009008-CH) and the Michigan Court of Appeals (No. 343630), with plaintiffs/counterdefendants-appellants Schaaf, Fryer, and Mason against defendant/counterplaintiff-appellee Forbes. The order is procedural only, setting a deadline for submission of the amicus briefs, and does not address the merits. ****Key legal topics:**** amicus curiae, real property, probate and estate planning, Michigan Supreme Court procedure, appellate practice.
