SUMMARY

The United States District Court for the Middle District of Alabama granted the Commissioner of Social Security’s unopposed motion for entry of judgment with remand. The court reversed the Commissioner’s decision and remanded the matter for further administrative proceedings under sentence four of 42 U.S.C. § 405(g).

PROCEDURAL POSTURE	Plaintiff sought judicial review of a Social Security disability decision. The Commissioner filed an unopposed motion for entry of judgment and sentence-four remand for further administrative proceedings.
STANDARD OF REVIEW	Under sentence four of 42 U.S.C. § 405(g), remand is appropriate when the Commissioner's decision is not supported by substantial evidence or when the Commissioner or administrative law judge incorrectly applied the law relevant to the disability claim.

1. Whether the district court should grant the Commissioner's unopposed motion for a sentence-four remand under 42 U.S.C. § 405(g).

HOLDINGS

1. The court granted the Commissioner's unopposed motion, reversed the Commissioner's decision, and remanded the matter for further proceedings under sentence four of 42 U.S.C. § 405(g).

The court granted the motion, reversed the Commissioner's decision, and remanded under sentence four of 42 U.S.C. § 405(g).
