The opinion provides no substantive facts concerning the underlying offense. The appeal concerned only whether the sentence imposed by Supreme Court, Bronx County, was excessive.

PROCEDURAL HISTORY

The Supreme Court, Bronx County, rendered judgment on February 26, 2025. Tyresse Minter appealed to the Appellate Division, First Department, which unanimously affirmed after argument, finding that the sentence was not excessive.
