Matter of Key Constr. Servs., LLC v. County of Westchester

2026 NY Slip Op 01361 · No. 2023-11239 · Decided March 11, 2026

SUMMARY

The New York Appellate Division, Second Department, affirmed dismissal of an Article 78 proceeding challenging a determination that Key Construction Services was responsible for telecommunications and information technology work under its contract with Westchester County. The court held that the contract documents conclusively established the petitioner’s responsibility for the work and noted that the petitioner had not identified the alleged ambiguity before bidding as required by the contract.

PROCEDURAL POSTURE	Petitioner appealed from an order and judgment that, in effect, granted the County's motion under CPLR 3211(a) to dismiss an article 78 petition and dismissed the proceeding.
STANDARD OF REVIEW	On a CPLR 3211(a)(1) motion, the movant must provide documentary evidence that utterly refutes the petitioner's factual allegations and conclusively establishes a defense as a matter of law. On a CPLR 3211(a)(7) motion, the court accepts the pleaded facts as true and gives the petitioner the benefit of every favorable inference. When evidentiary material outside the pleading's four corners is considered without converting the motion to summary judgment, the question is whether the pleader has a cause of action.

QUESTIONS PRESENTED

1. Whether documentary evidence conclusively refuted the petitioner's allegation that it was not contractually responsible for the telecommunications and information-technology work, warranting dismissal under CPLR 3211(a)(1).
2. Whether the petitioner's failure to comply with the contract provision requiring bidders to inquire about ambiguities before bidding supported dismissal of the article 78 proceeding.

HOLDINGS

1. Dismissal was proper because the contract documents, including Addendum No. 1 and the attached drawings, utterly refuted the petitioner's allegation that the telecommunications and information-technology work was outside its contractual responsibility and conclusively established a defense as a matter of law.
2. The petitioner could not avoid its contractual responsibility where it failed to comply with the contract's requirement that bidders discover and inquire about ambiguities in the plans, specifications, or contract before submitting a bid.

FACTUAL BACKGROUND

Key Construction Services was the successful bidder on a White Plains building-renovation project and entered into a contract with Westchester County in August 2021. The company disputed that the contract required it to perform specified telecommunications and information-technology work. The County Commissioner determined on October 17, 2022, that the company was clearly responsible for completing that work, including purchasing and installing related equipment, as contract work rather than extra work. The contract documents and Addendum No. 1 identified the disputed work and stated that work shown on the drawings was part of the contract work.

PROCEDURAL HISTORY

Key Construction Services commenced a CPLR article 78 proceeding challenging a determination by the Commissioner of the County of Westchester Department of Public Works and Transportation that the company was contractually responsible for telecommunications and information-technology work. The County moved to dismiss under CPLR 3211(a). Supreme Court, Westchester County, granted the motion in effect and dismissed the proceeding. The Appellate Division affirmed, with costs.
