DeVante Davis v. Warden

SUMMARY

The United States District Court for the Middle District of Pennsylvania dismissed DeVante Davis’s 28 U.S.C. § 2241 petition challenging the Bureau of Prisons’ denial of a sentence reduction for completing the Residential Drug Abuse Program. The court held that Davis’s conviction for being a felon in possession of a firearm disqualified him from the reduction under 28 C.F.R. § 550.55(b), and that the denial did not depend on classifying his offense as a crime of violence.

PROCEDURAL POSTURE	Petitioner sought habeas relief under 28 U.S.C. § 2241, requesting a one-year sentence reduction based on completion of the Residential Drug Abuse Program. The district court summarily dismissed the petition under Rule 4.
STANDARD OF REVIEW	Under Rule 4 governing § 2254 cases, applied to § 2241 petitions through Rule 1(b), the court may summarily dismiss a petition when it plainly appears from the petition and attached exhibits that the petitioner is not entitled to relief.

QUESTIONS PRESENTED

1. Whether Davis was entitled to habeas relief under 28 U.S.C. § 2241 based on the Bureau of Prisons' denial of an RDAP sentence reduction.
2. Whether a felony conviction for being a felon in possession of a firearm disqualifies an inmate from an RDAP sentence reduction under 28 C.F.R. § 550.55(b)(5)(ii).
3. Whether the Bureau of Prisons denied the reduction by improperly classifying Davis's offense as a crime of violence.

HOLDINGS

1. Davis was not entitled to habeas relief because his conviction for being a felon in possession of a firearm disqualified him from an RDAP sentence reduction under the applicable regulation.
2. The record did not show that the BOP classified Davis's conviction as a crime of violence; the BOP instead relied on the firearm-based exclusion in the current version of 28 C.F.R. § 550.55(b).

“If it plainly appears from the petition and any attached exhibits that the petitioner is not entitled to relief in the district court, the judge must dismiss the petition and direct the clerk to notify the petitioner.”

“Federal courts are authorized to dismiss summarily any habeas petition that appears legally insufficient on its face.”

FACTUAL BACKGROUND

Davis was sentenced to 65 months' imprisonment after pleading guilty to being a felon in possession of a firearm and possessing fentanyl with intent to distribute. He completed the Residential Drug Abuse Program and sought a one-year sentence reduction under 18 U.S.C. § 3621(e)(2). The Bureau of Prisons deemed him ineligible because his current commitment involved a felony conviction involving possession of a firearm under 28 C.F.R. § 550.55(b), rather than because the offense was classified as a crime of violence.

PROCEDURAL HISTORY

Davis was sentenced in the Eastern District of Missouri after pleading guilty to being a felon in possession of a firearm and possessing fentanyl with intent to distribute. While incarcerated at FCI-Schuylkill, he filed a § 2241 petition challenging the Bureau of Prisons' determination that he was ineligible for an RDAP sentence reduction. After granting extensions concerning payment of the filing fee or an in forma pauperis application, the court received the filing fee and dismissed the petition.
