FACTUAL BACKGROUND

The court reporter stated that the reporter's record had been completed but could not be transmitted in an acceptable format. After several unsuccessful attempts and consultations with court personnel, the reporter requested a fifteen-day extension to resolve the technical problem and submit the record.
