FACTUAL BACKGROUND

The appellate brief was due on May 1, 2019. On that date, appellant requested an additional sixty days to file the brief.

PROCEDURAL HISTORY

The appeal was pending in the Fourth Court of Appeals of Texas from the 379th Judicial District Court of Bexar County, Texas. Appellant's brief was due May 1, 2019, and appellant moved that day for an additional sixty days to file it. The court granted the motion in part and denied it in part, ordering the brief filed by May 31, 2019.
