1. Whether to grant the court reporter an extension of time to file the reporter's record.

FACTUAL BACKGROUND

The reporter's record in the appeal had not yet been filed. Anita Garza, the court reporter for the 171st District Court of El Paso County, requested an extension of time. The appellate court granted the request through December 30, 2020.

PROCEDURAL HISTORY

The appeal was taken from the 171st District Court of El Paso County, Texas, in trial-court cause number 2016DCV3160. The court granted Anita Garza's request for an extension of time to file the reporter's record and ordered that the record be forwarded by December 30, 2020.
