SUMMARY

The United States District Court for the Northern District of Alabama adopts a magistrate judge’s Report and Recommendation and dismisses Chakevia Roberts’s 28 U.S.C. § 2241 habeas petition without prejudice for failure to prosecute. The court notes that Roberts did not file objections within the permitted period and reviews the unchallenged recommendation for clear error.

QUESTIONS PRESENTED

1. What standard of review applies when a party does not object to a magistrate judge's Report and Recommendation?
2. Whether the Report and Recommendation recommending dismissal of Roberts's § 2241 petition for failure to prosecute should be adopted and the action dismissed without prejudice.

HOLDINGS

1. When no specific objections are filed, the district court reviews the unchallenged portions of a magistrate judge's report and recommendation for clear error.
2. The magistrate judge's recommendation to dismiss the habeas action for failure to prosecute was accepted and adopted, and the action was dismissed without prejudice.

KEY QUOTATIONS

“Accordingly, the Court ORDERS that this action is DISMISSED WITHOUT PREJUDICE for failure to prosecute.”

FACTUAL BACKGROUND

Roberts filed a petition for a writ of habeas corpus under 28 U.S.C. § 2241. The magistrate judge recommended dismissal for failure to prosecute. Roberts did not file objections to the Report and Recommendation within the fourteen-day objection period.

PROCEDURAL HISTORY

Magistrate Judge Nicholas A. Danella issued a Report and Recommendation on January 21, 2026, recommending dismissal of Roberts's § 2241 petition for failure to prosecute. Roberts was notified of her right to object but filed no objections within the prescribed period. The district court reviewed the unchallenged recommendation for clear error, adopted it, and dismissed the action without prejudice.
