PROCEDURAL HISTORY

The appeal was docketed in the Supreme Court of Nevada on December 30, 2021, from the Eighth Judicial District Court in Clark County, case A709372. The Supreme Court issued an order to show cause regarding jurisdiction, and the parties filed responses and extensions. On July 14, 2022, the parties jointly moved to dismiss the appeal; the court granted the motion on July 21, 2022, closed the case, and issued no remittitur.
